In continuation to the Board's notice dated 29.06.2022, the special link for inviting online application from the 61278 candidates to whom admit cards were issued earlier by the Board for the Tier-I examination held on 29.06.2014 for the post of Grade-II (DASS) under post code 90/09 will be opened between **21.11.2023 to 20.12.2023 (11.59 PM)** on the website <https://dsssbonline.nic.in>. In case of non-receipt of online application from the candidate, it will be construed that the candidate is not interested to apply again for the post of Gr.-II (DASS) under post code-90/09 and no further opportunity will be extended to him/her and any correspondence in this regard will not be entertained. Interested candidate is required to apply for the post code 90/09 through the special link provided at the website [dsssbonline.nic.in](https://dsssbonline.nic.in). Candidate has to fill the details of application ID and DOB for registration for the post code 90/09. Then click on register yourself for OARS, fill the details of 10th roll no. and 10th passing year. The data provided by the candidate will be matched with the previous data, if data is matched then the candidate has to upload any one document from the list and submit. After this a message will pop up that document uploaded successfully. Then the candidate has to apply for the post through sign-in for applying for the post code. Any candidate who has never registered himself on OARS is required firstly to register himself/herself as a new user at the website [dsssbonline.nic.in](https://dsssbonline.nic.in). After successful registration, candidate is required to apply for the post code 90/09 through the special link provided at the website [dsssbonline.nic.in](https://dsssbonline.nic.in). Candidates are also advised to fill up the online application well before the closing date. Candidates may contact in person at helpdesk in DSSSB or communicate through the e-mail ID [helpdesk.pnp.90.09@gmail.com](mailto:helpdesk.pnp.90.09@gmail.com), any problem/technical issue in filling of online application on OARS. The above helpdesk and e-mail ID will remain functional during the opening period of the special link.

**Only online applications will be accepted. Applications received by post/by hand/by mail etc. will not be accepted and will be summarily rejected. No correspondence will be entertained in this regard. Candidates are also warned that if any candidate fill up the online application other than 61278 candidates to whom admit cards were earlier issued by the Board for the Tier-I Exam held on 29.06.2014 under Post code-90/09, will be debarred for future DSSSB examinations.**
